REPORT:	The proposed Cisco Networking Less Than One-Year Certificate is designed to prepare students who wish to work in the field of computer networking. This 16-credit certificate is aimed at fulfilling the IT needs within the Portland-Metro area, allowing those already in the field to expand their skill set, or introducing these high-demand skills to a new audience.
RECOMMENDATION:	That the College be authorized to submit an application to the Higher Education Coordinating Commission for the Cisco Networking Less Than One-Year Certificate for Portland Community College.
