## **PREREQ-FP01: Fire Protection Technology Prerequisites**

• Updated reading prerequisite.

#### ACERT1-MM: Multimedia Less Than One-Year Certificate

- Removed MM 110, MM 130, MM 140, MM 150.
- Added MM 112, MM 231, MM232.
- Total certificate credits increased from 60 to 61 credits.

## **AAS-ID: Interior Design AAS Degree**

• ID 111 is being replaced with ID 238.

## **ACERT1-MA: Medical Assisting Dental Assisting One-Year Certificate**

- Removed MA 180.
- Removed Human Relations elective courses (there is enough related instruction within existing program courses to meet requirements for the Human Relations elective).
- Total certificate credits decreased from 52 credits to 46 credits.

### **AAS-MSA: Music & Sonic Arts AAS Degree**

- Swapped out MUC for MUS equivalent courses and combined the curriculum; these two music programs had duplicate courses.
- Added WR 121 into the degree plan for students.

## ACERTP-MSAC: Music & Sonic Arts Less Than One-Year Career Pathway Certificate

• Swapped out MUC for MUS equivalent courses and combined the curriculum; these two music programs had duplicate courses.

## ACERTP-GRP: Gerontology Less Than One-Year Career Pathway Certificate

- GRN 181 increased from 2 credits to 3 credits to incorporate new curriculum content from the discontinued GRN 280B Gerontology Internship Seminar course.
- GRN 201 increased from 2 credits to 3 credits to add some needed additional assignment structures.
- GRN 280A reduced the required number of credits from 4 credits to 2 credits to align with the standards of the International Gerontological Society on Aging.

## **AAS-GREN - Gerontology AAS Degree**

• GRN 181 credits increased from 2 credits to 3 credits to incorporate new curriculum content from the discontinued GRN 280B Gerontology Internship Seminar course.

• GRN 201 credits increased from 2 credits to 3 credits to add additional assignment structures.

• GRN 280A credits reduced from 4 credits to 2 credits to better reflect International Gerontological

Society of America/Academy for Gerontology in Higher Education standards.

• Added HUS 102 as an alternative to HUS 107 since HUS 107 is only offered once a year (it was

also cancelled in fall 2023).

• Total certificate credits increased from 38 to 39.

**AAS-DH - Dental Hygiene AAS Degree** 

• Added new courses, updated course names, added seminar classes, added radiology curriculum,

doubled periodontology curriculum.

• Updated all outcomes.

• Program length decreased from 21 months to 18 months by eliminating summer term.

• Total degree credits increased from 105 to 106.
